DISTRIBUTED (DECENTRALIZED) MEDICAL EDUCATION – BACKGROUND

- PRESSURE TO INCREASE ENROLLMENT

- SHORTAGE OF SUITABLE CLINICAL EXPERIENCES
- MISMATCH BETWEEN TRAINING SITES and AREAS OF NEED, URBAN vs. RURAL, REMOTE

CONCERNS

 UNKNOWN ENTITY/OVERWORKED
- LOSS OF CONTROL OF EDUCATIONAL PROCESS
- LACK OF BASIC SCIENCE TUTORS (and RESEARCH)





Physicians and Quality of Care of Canadian Francophone Minority Communities: A Commitment from AFMC

Francophone minority communities (FMC) represent a significant population (1 million individuals) distributed throughout Canada. Previous studies have demonstrated that the health of this population is worse than that of the majority of the population. Lower accessibility to health care and services are often attributed to difficulties of recruitment and retention of physicians in these communities as well as underdeveloped health services


